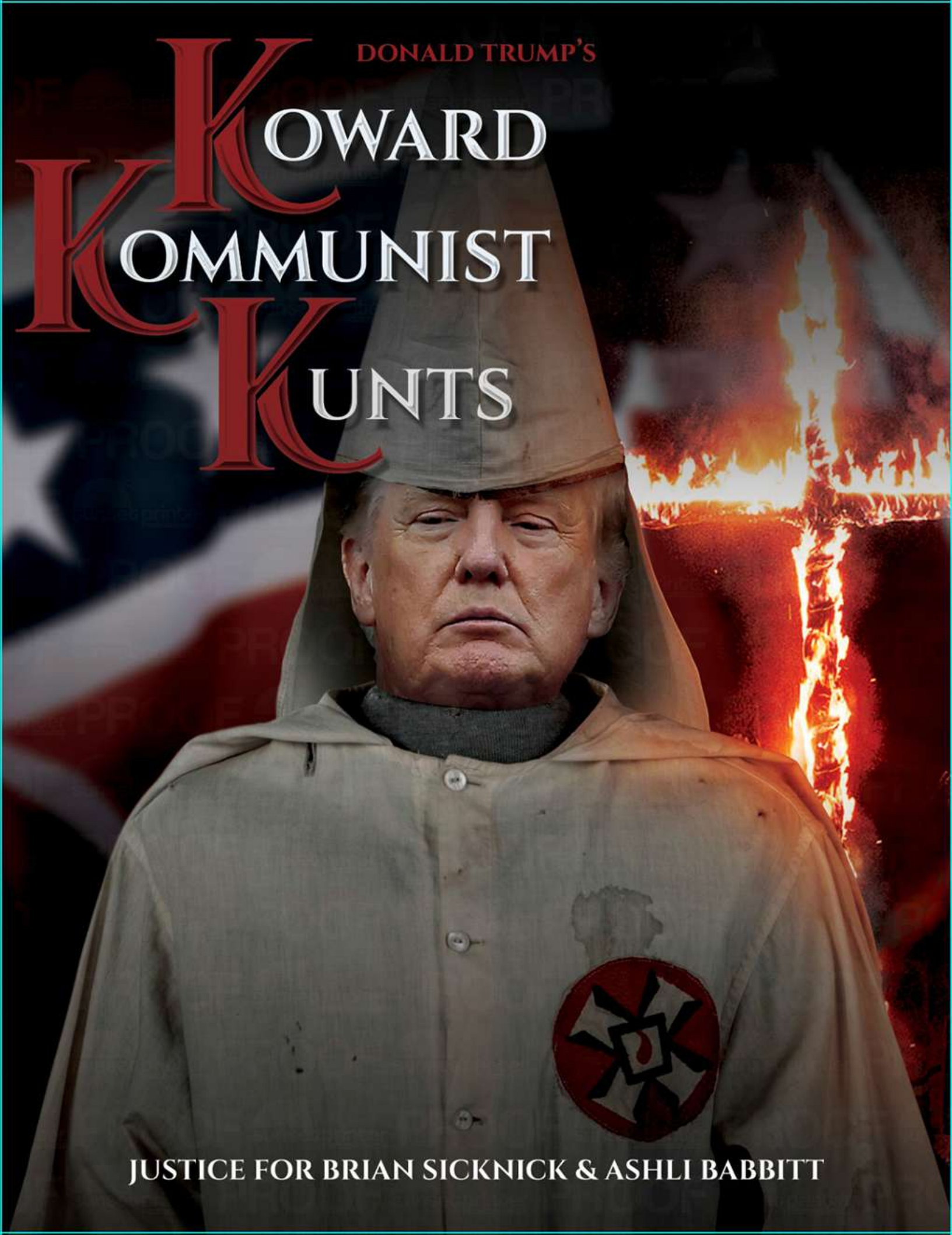

Donald Trump's cowardly communist cunts are many. The following are some of the problems I've had with Donald Trump's KKK.

Tuesday, October 11, 2022, 7pm, Signal Hill city council meeting. I spoke with Paulson at 333 West Broadway, suite 200, Long Beach. He called the Signal Hill Police Department on my behalf. Next time I went to see Paulson, the secretary said he wasn't

The Southern California News Group ad agent Sari Montrone, [smontrone@scng.com](mailto:smontrone@scng.com) . The LA Focus Kisha Smith, [lafocus@aol.com](mailto:lafocus@aol.com) . These ad agents, and I, agreed on the ad, the price, the times to place the ads, and none would place my ad. They are Trump KKKs, or they've been KO'd by Trump's KKK. We'll have to ask why they won't honor the advertising contract.

I took a plane up to the San Francisco area. I had the taxi driver drive me to the San Francisco Chronical newspaper. Trump had 2 guys in front of the door. I told them I had a news tip. They told me I couldn't go in. I had to send an email. Me, "For a news tip?" KKK goons, "You can't go in the building." After flubbing for a reason, "covid." This was after the pandemic. *We are sorry to inform you that your ad material for Order #7922258 has been rejected as it does not meet acceptable content requirements for the Los Angeles Times. We will be issuing a refund to your credit card.*

Does the LA Times read entire books before they allow a book to be advertised? What material or content is not acceptable? Trump's KKK are everywhere. They must block the book from being read. No one can know about Trump smuggling drugs via the border wall truck traffic.

I received a phony email from Congressman Adam Schiff, 150 E. Olive Ave, suite 208, Burbank CA. I didn't know if it was real. I went there without calling. There was no name on the door.
